# 4. ANNOUNCEMENTS FROM THE PRESIDING MEMBER

- The Manager of Works and Services and the President recently attended a Regional Road Group committee meeting. Funding has been reduced significantly by the State Government.
- The CEO and President recently attended a public meeting at the premises of the Burakin Hall, which
  has been closed to the public due to asbestos risk. It was agreed that the Hall will be demolished, and
  the Shire will provide a sea container, gazebo and interpretative signage on the site to allow Burakin
  residents to retain and display their heritage.
- The Shire has been involved in two recent Local Emergency Management Committee meetings, one a desktop exercise in Dowerin.
- The Citizen of the Year Function will be held on Friday 6 April 2017.

• The CEO's review was conducted recently by the President and the Deputy President, and the CEO will present a self assessment after this meeting.

Mrs Pam Toster presented to the Council regarding her concerns around over-clearing of native vegetation on road verges. Mrs Toster presented a number of photographs from this and other Shire's, showing areas of clearing and areas of rehabilitation, as well as a number of pieces of correspondence to and from the Shire noting the above concerns. It was acknowledged that the Shire had recently adopted a policy on this issue and was working within the framework and legislation.

Mrs Toster requested the Council consider forming a collaborative working relationship with other community groups such as Landcare to rehabilitate areas that have been previously cleared, that Council increase the Shire's own rehabilitation practices and that the Shire's operational practices around roadworks be reviewed and amended to reflect a better conservation outcome for road reserves.

- (c) Grant an extension of development approval for up to two (2) years;
- (d) Granting variations to relevant Planning Policies and provisions of the Residential Design Codes on Building Licence applications;
- (e) Determination of applications for development approval for buildings on land Zoned Rural Residential, including Dwellings, Sheds, Carports and other similar buildings, but excluding Transportable Buildings.
- (f) Deletion or modification of conditions of approval, whether imposed under delegated authority or not;
- (g) Making recommendations to the WA Planning Commission on:
  - i. applications for subdivision or amalgamation of land;
  - ii. minor variations to approved subdivisions;
  - ii. clearance of conditions of subdivision approval;
- (h) Determination of Applications for the relocation of Building Envelopes;
- (i) Provision of written and verbal responses to planning appeals, mediated settlements resulting from appeals and WA Planning Commission requests for reconsideration;
- (j) Taking all necessary action against owners or occupiers of properties to cease illegal

- uses or comply with conditions of Development Approval, including pursuing prosecution through Council's Solicitors; and
- (k) Formation of any opinion and consideration of any matter in the exercise of these delegated powers that would be required of Council under the Scheme, including, but not limited to, sufficient information required for the processing of applications, referral and advertising of applications, and interpretation of Scheme provisions, relevant Planning Policies and provisions of the Residential Design Codes.

# Limits to delegated powers

With the exception of delegated power 1.(b) above, all applications will be submitted to a meeting of Council for determination in the following circumstances:

- (a) Where the delegated decision would be contrary to the intent of a previous decision made at a Council meeting, or any law or regulation;
- (b) Where written objection is received to the proposal from any statutory agency;
- (c) Where the proposal is inconsistent with the intent of the Town Planning Scheme, relevant Policies, Residential Design Codes, or any Outline Development Plan or Local Planning Strategy adopted by Council;
- (d) Where notification has been given to adjoining and nearby owners or the general public for comment in accordance with the Town Planning Scheme or any Policy and written objections have been received within the time specified, unless in the opinion of the Chief Executive Officer:
  - (i) the proposal is for exercise of discretion under the R-Codes and is consistent with the intent of the Town Planning Scheme, Residential Design Codes and any relevant Policy; and
  - (ii) the objections can be overcome by imposing a condition(s) on the development approval, or modifying the design of the development; or
  - (iii) the objection does not relate to valid planning and development issues associated with the proposal.
- (e) Where, in the opinion of the Chief Executive Officer:
  - (i) Any of the requirements of this policy are not satisfied; or
  - (ii) There is insufficient certainty as to whether the application complies with the intent of the Scheme, Residential Design Codes or any relevant Council Policy; or
  - (iii) It would be in the public interest or consistent with the principles of administrative accountability for Council to determine the application; or
  - (iv) The decision involves a matter of principle which, in the opinion of the Chief Executive Officer, should be made by the Council; or
  - (v) A condition recommended by a statutory agency is unnecessary or impractical, or unreasonable to be enforced by the Shire.

Council has adopted 10% as its threshold for line items on the nature and type report shown on page 1. This report uses a traffic light system to flag those items that are within tolerance and others that fall out of the range. Variances are calculated using a comparison of year to date actual against year to date budget. It needs also to be noted that the early months of the financial year are a period when variance percentages are volatile and extremely sensitive to small movements in actual income and expense.

0	Materials & Contracts	There are some individual line items that are under-budget mainly because of the timing of programmed works or activities. There are minor variances within many accounts in this category, adding up to a under budget variance.
×	Utilities (Gas, Electricity) etc	Utility charges are slightly over budget, this is timing variance.
0	Interest	The shire had budgeted for interest expenditure for the new self-supporting loan that was budgeted for this financial year. This loan was only drawn down in October and November.
0	Other General	The line item for Community Grants is under budget. The budget predicted that more payments would have been made by the end of January. This is a timing issue as payments are being made to community groups.
×	Loss on Asset Disposals	This is a timing variance, changeovers of fleet and plant have commenced and there are always variations to budget due to many factors including timing in the budget, trade in variances to budget etc. The overall program is in-line with budget expectations.
0	Depreciation	When preparing the 2017/18 budget, depreciation was estimated on the value of the assets at the time (some classes of assets were revalued at the 30 <sup>th</sup> June to reflect their fair value) and with the change in values, and updated depreciation rates the monthly charge is different to the budget.

Traditionally, only the applicant has a right to appeal a determination for an application for development approval. In November 2017, WALGA initiated consultation via workshops where additional feedback from WALGA members was gained. The feedback culminated into a single preferred model, that WALGA "Support the introduction of Third Party Appeal Rights for decisions made by Development Assessment Panels.

This report is referred to Council for its consideration as WALGA requests Council Resolutions as feedback rather than officer/staff feedback.

### **BACKGROUND:**

Third Party Appeal Rights in Planning has been an ongoing discussion in Western Australia for many years. Third Party Appeal Rights were considered in 2001 during debate on the new planning appeal system and again the following year during the State Government's consolidation and development of the new Planning and Development Legislation.

In 2007, a private Member's Bill was proposed by the then Member for Alfred Cove, which was modelled on Victoria's Planning and Development Act 1987. The justification for the introduction of the Bill was primarily based on Western Australia being the only state without third party appeals. The Bill however failed to acknowledge that significant differences exit between the Victorian and Western Australian planning systems.

At the February 2008 meeting of State Council, WALGA formed a Policy position against the introduction of Third Party Appeal Rights. The report noted that the main arguments against the proposal were:

- (a) The current strategic and statutory planning processes, and consideration of applications by Councils, already takes into account the views of affected parties and the community generally;
- (b) Third party appeals could be lodged because of vexatious or commercial interests, not because of genuine planning matters;
- (c) Such appeals would cause significant delays and additional costs for development, as even lodgement of an appeal would put a development on hold; and
- (d) Additional planning appeals would place a further burden on already stretched Local Government resources. Local Governments would incur additional costs for new administrative steps in processing development applications, preparing for and responding to appeals lodged with the State Administrative Appeals Tribunal (SAT) and legal representation. This is particularly the case since the establishment of the State

Administrative Tribunal which has (seen) planning appeals become more legalistic, costly and resource intensive for Local Governments.

The current State Administrative Tribunal (SAT) system was considered to be an efficient means to reconsidering the merits of planning applications and there were existing ways for a third party to participate in a planning matter being considered by SAT, namely;

- (i) Being called as a witness by the respondent;
- (ii) Making a submission under section 242 of the *Planning and Development Act 2005;*
- (iii) Intervening under section 37(3) of the *State Administrative Tribunal Act 2004*, where by the third party acquires rights and responsibilities as a party under the Act; and
- (iv) Possible participation in mediation.

Given this consideration the Bill was not supported and Third Party Appeal Rights have continued to be not supported.

With the advent of Development Assessment Panels (DAP's) in WA, a general disregard for community wellbeing has been reported. This is likely because the majority of applications made to DAPs have been significant beyond community expectations (though primarily still within statutory limitations), a lack of understanding of the planning framework, and generally involve the replacement of small scale buildings with large scale buildings. Hence with minimal local representation, many local authorities consider the process not forthcoming with community engagement expectations.

Therefore, WALGA have committed to providing Government with a recommendation for the introduction of Third Party Appeal Rights in WA following the advent and review of DAP's.

### COMMENT:

The introduction of Third Party Appeal Rights is not the ultimate answer to the reduction of community values within the planning process.

If the issue is with the DAP process, this should be rectified within DAP's legislation.

The introduction of Third Party Appeal Rights is unlikely to significantly improve the DAP process.

WALGA's request for feedback relates typically to whether a particular model of Third Party Appeal Rights should be introduced for DAPs determinations. This seems a straight forward request, though is limiting because it apparently does not reflect the previous vote. The previous vote, which is referenced in the attached document, was skewed to not being in favour at all of Third Party Appeal Rights.

Council is recommended to support WALGA's position, with additional advice recommending WALGA to review alternatives to Third Party Appeal Rights.
